Case study Salford's Journey to 'Whole Systems' working Partners IN Salford, Salford's local strategic partnership, has a track record of experimentation and innovation in partnership working. In 2007 the partnership started working with a team of neighbourhood renewal advisors planning the delivery of its first Local Area Agreement (a multi-agency agreement on local priorities). The partnership needed to develop an awareness of how the complex issues facing the city were linked to one another. A series of conversations (using open space techniques) were held on various Local Area Agreement themes for example, worklessness, health, and the environment. These conversations helped the partnership understand itself better as a system. Hundreds of people across the system participated, sometimes in several of the thematic conversations. Partners IN Salford has committed itself to using the principles of 'whole systems working'. It moves beyond thinking about issues in professional silos. Whole Systems thinking requires you to •understand how systems operate and interlink: at both a micro level (such as families, neighbourhood and village communities, and work teams) and macro level (such as large organisations, politics and the economy). For example, in the case of worklessness how does Job Centre Plus, local community and voluntary sector provision, and the decisions of those who are seeking employment fit together? •use tools and approaches which foster 'whole systems' working, where planning, research and evaluation seek to engage the full range of stakeholders including services 		planning documents or the determination of planning applications, and is therefore of limited relevance to the SCI.
